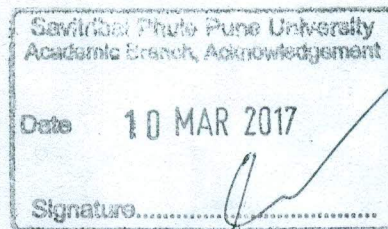
We have taken appropriate care to see that our Grade B+ is equivalent to 55% which is on par with the Grading System prescribed by the Savitribai Phule Pune University.


