# MEMORANDUM OF UNDESTANDING

This Memorandum of Understanding (MOU) made on Monday, 4<sup>th</sup> January, 2022 at Pune.

#### **BETWEEN**

St. Mira's College For Girls, 6, Koregaon Road, Near Hotel Blue Diamond, Pune, Maharashtra 411001, through the Principal, of the One Part.

#### AND

The Institute of Cost Accountants of India – Pune Chapter, a statutory body set up under an Act of Parliament, having its office at CMA Bhawan, Sr.No.22, hissa No.1+2/2b, CTS No.323, Canal Road, Lane No. 2, Vikas Mitra Mandal Chowk, Karvenagar, Pune 411052 hereinafter referred to as 'ICAI- Pune Chapter' which expression shall unless repugnant to the context or meaning thereof includes its successors and permitted assigned, of the Second Part;

ICAI-Pune Chapter and the St. Mira's College For Girls are hereinafter referred individually as 'party' and collectively as 'parties'.

WHEREAS St. Mira's College For Girls is one of the premier college in Pune, providing education and research facilities in various areas of Commerce, Science, & Arts discipline;

AND WHEREAS ICAI-Pune Chapter is one of the oldest and most vibrant chapters of The Institute of Cost Accountants of India involved in the activities of Education and Professional Development as per the relevant Act & Regulations and having a long standing relation and cooperation with various Educational, Professional, Industrial & Government bodies in and around Pune.

By this MoU, the parties hereto have decided to cooperate; collaborate and further agree as under:

# A. Objective:

The general objective of this Memorandum of Understanding (MOU) is to extend academic co-operation between ICAI-Pune Chapter & St. Mira's College For Girls specifically in the domain of Cost Accounting, Management Accounting, Financial Management, and other related areas and to stimulate and facilitate the





development of collaborative and mutually beneficial programs, which will serve to enhance the intellectual level and cultural development in both organizations.

# 1. Career Counseling Programs:

- ICAI-Pune Chapter will conduct Career Counseling Sessions for the students
  of St. Mira's College For Girls to sensitize the students about career
  opportunities through the Course of Cost Accountancy and allied courses
  offered by The Institute of Cost Accountants of India and all other Courses
  offered by The Institute of Cost Accountants of India.
- ICAI-Pune Chapter will carry out the Career Counseling Session as a voluntary activity for the St. Mira's College For Girls.
- St. Mira's College For Girls will make all the necessary arrangements including infrastructural support for these career counseling sessions.
- The Schedule for the Career Counseling Session will be decided by the parties with mutual convenience.
- St. Mira's College For Girls will give necessary publicity to the Career Counseling Session to be conducted by ICAI-Pune Chapter.

# 2. Guest Lectures in the Domain of Cost & Management Accounting:

- ICAI-Pune Chapter will arrange guest faculties with practical experience to share their knowledge and practical experience on topics in the domain of Commerce, Finance, Cost & Management Accounting, Income Tax, Indirect Tax, Information Technology & other topics associated for the students of St. Mira's College For Girls.
- The parties will decide Topic, Date, Time and Venue as per mutual convenience.
- The Guest Lectures can be arranged in Online or Offline mode as per the mutual convenience of the parties.
- St. Mira's College will make all the necessary arrangements including Infrastructural Facilities in case of the Offline mode of Guest Lectures.

# 3. Practical Training – Internships to the Students of St. Mira's College For Girls:

 ICAI-Pune Chapter will appeal its members both in Industry & Practice to assist students of St. Mira's College For Girls to get practical training – Internships specifically in the domain of Cost & Management Accounting, Indirect Taxation and related areas for a short duration of 50 – 70 Hrs.





- ICAI-Pune Chapter & St. Mira's College For Girls will create a necessary mechanism & decide other working modalities for this Practical Training Scheme with mutual convenience & discussion.
- ICAI-Pune Chapter will conduct a lecture on setting expectation from students while at workplace during practical training, every year.
- **4.** The ICAI-Pune Chapter will provide assistance in arranging and organizing Industry Visits for students of Cost Accounting of St. Mira's College for Girls in order to increase the subject related exposure.

# Participation in the CEPs (Continuous Education Programs) conducted by ICAI-Pune Chapter:

- ICAI-Pune Chapter conducts CEPs for its members & students. ICAI-Pune Chapter will circulate information about all such programs to St. Mira's College For Girls which is to be further passed on to Students & Faculty of the St. Mira's College For Girls by the college.
- Students of St. Mira's College For Girls can attend the CEP Programs of the ICAI-Pune Chapter as fees similar to that of the students of ICAI-Pune Chapter.
- Faculty of St. Mira's College For Girls can attend the CEP Programs of the ICAI-Pune Chapter as fees similar to that of the Members of ICAI-Pune Chapter.

# 6. Faculty Development Programs:

- ICAI-Pune Chapter will carry out Faculty Development Programs for the Faculty of St. Mira's College For Girls.
- The details of the program including financial considerations will be decided by the parties on case to case basis considering mutual convenience.

# 7. Sharing of Library Facilities:

- ICAI-Pune Chapter will share library membership only with Faculty of St. Mira's College (on payment of prescribed fees).
- St. Mira's College will share library membership with the Members of ICAl-Pune Chapter (on payment of prescribed fees)





#### 8. Use of Infrastructure:

Both the parties have their own Infrastructure Facilities. The parties hereby agree to allow use of each other's Infrastructure on mutually convenient terms to be decided on case to case basis.

## B. Binding of the MOU:

- 1. Nothing in this MOU shall be construed to make either party a partner, an agent or legal representative of the other for any purpose.
- 2. The parties hereby agree that they are not bound exclusively by this Memorandum and shall be at liberty to enter into any separate agreements or arrangements with any third party without reference to the other party. However, each party will disclose similar arrangements they enter into with third parties.
- Cost and expenses involved in the implementation of this MoU will be borne by each on individual basis.
- 4. This MOU does not create any Financial Obligation towards each other in whatever manner. All the Financial Engagements and Commitments for any of the objects prescribed under this MOU will be decided by the parties with mutual consultation & convenience on case to case basis.

# C. Terms and Termination:

- This MOU shall come into force on the date of its signing by the authorized representatives of the parties hereto and shall remain in force for a period of 2 years and thereafter it may be further expended with written mutual consent of the parties.
- Either party may terminate this MoU by giving 3 months' prior notice in writing to the other Party explicitly mentioning the reason(s) thereof, dishonoring any commitment made prior to the date of termination notice.





#### D. Dispute Resolution:

Any difference or dispute between the Parties concerning the interpretation and/or implementation and/or application of any of the provisions of this Memorandum of Understanding shall be settled amicably through mutual consultation and/or negotiation between the Parties, without recourse to any third party or court.

# E. Confidentiality, Intellectual Property and Use of Name & Logo:

- Each party shall understand to observe the confidentiality and secrecy of documents, information and other data received from or given to the other Party during the period of the implementation of this MOU or any other agreements made pursuant thereto.
- 2. The protection of intellectual property rights shall be enforced in conformity with the laws, rules and regulations in force from time to time.
- 3. Each party may use the name, logo and/or official emblem of other party for the purposes of this MoU with the prior written approval of other Party.

#### F. Amendment:

- 1. Either Party may request in writing a revision, modification or amendment of all or any party of this Memorandum of Understanding, and any revision, modification or amendment agreed to by the Parties shall be presented in writing and signed by authorized representatives of both the Parties. Such amendment/s shall form part of this Memorandum of Understanding.
- Both the parties will review the activities on quarterly basis at the place/location agreed mutually.

#### G. Contacts:

Each party hereby designates and appoints its representative with overall responsibility for implementing this memorandum and the representatives are duly authorized to sign the MOU. Single Point of contact from ICAI-Pune Chapter will be The Chairperson of the Chapter. The Parties may, by written notice to the

- 3.4.6 The Agreement would facilitate cooperation in the transfer and exchange of knowledge and expertise, sharing of resources, capacity building and training of personnel.

#### 3.5Centre for Women Entrepreneurship(CWE) St.Mira's College for Girls, Pune agrees to:

- 3.5.1 Provide training and guidance on business and organizational aspects of the venture such as marketing, branding, financial management, human resource management etc to the Incubateeventures through its master trainers/mentors
- 3.5.2 Facilitate funding to the social ventures/enterprises (that fulfil incubation conditions) through its investor network on a case to case basis

- 3.5.5 Agrees to take care of travel, stay, food etc for the resource persons as per the TISS travel policies.
- 3.5.6 Allow TISS to report the ventures incubated as part of this joint programme in their database as co-incubatees
- 3.5.7 Support/work jointly in conducting research and impact assessment studies.
- 3.5.8 Work jointly in promoting courses in entrepreneurship, social entrepreneurship or any topic as decided mutually.
- 3.5.9 Work jointly in student exchange, faculty exchange, FDP's etc. programs.

#### 4. Public Relations

Shroff College of Commerce, Bhulabhai Desai Road, Kandivali (West), Mumbai – 400 067 is established in the year 1989 as Private Educational Institute to provide higher education to build career in the field of Commerce, Management, and Humanities. Kandivali Education Society's B. K. Shroff College of Arts & M. H. Shroff College of Commerce is working under Dr. Lily Bhushan (Principal).

Here with St's Mira College for Girls, 6, Koregaon road, Pune, Maharashtra-411001, **Department of Economics and Business Economics** are in view of synergy in the objectives of the two organizations, it is desirable that the KES Shroff College and St's Mira College, Pune enter into Memorandum of Understanding (MoU) for making available the expertise and facilities existing in both the institutions for promoting training, academics, student teacher exchange and research in the field of common interest within the framework of charter of both the institutions for an initial period of **FIVE** years beginning from the academic year **2021-26**.

In accordance with a mutual desire to promote co-operation, KES Shroff College and St. Mira's College, Pune enter into this formal statement of collaboration, in educational, research and training endeavors.

KES' Shroff College and St. Mira's College, Pune have found it mutually beneficial to explore ex-operative activities with the following objectives.

- 1. To exchange of faculty and staff for research assignments.
- 2. To train students in projects and research and also for students exchange programmes.(online mode)
- 3. To organize symposia, workshops and conferences.
- 4. To organize Guest / Lead talks.
- 5. To carry out collaborative research programs.

The following are the terms of MOU:

- 1. The First party and the Second party based on the expertise available shall encourage joint research activity and projects.
- 2. The First party and the Second party will jointly submit Research proposals of mutual interests to Govt. and other Non-Govt. agencies for funding.
- 3. The First party and the Second party will jointly submit Research proposal of mutual interests to International Research Institutions for funding.
- 4. Intellectual Property jointly conceived or developed by the First Party and The Second Party will be jointly owned by KESSC and ST. MIRA. The First Party and The Second Party agree to collaborate towards the protection, if appropriate, and application of such Intellectual Property for commercial or other purposes on mutually acceptable terms to be negotiated in good faith between the parties.
- 5. Any other research / collaborative activities such as seminars, Conferences, workshops, consultancy, development of research data and facilities in all the areas for mutual benefit.
- 6. Organize short term training programs for students of KES Shroff College and St. Mira's College, Pune to make the learners knowledge oriented.
- 7. To provide project internships for post graduate and graduate students as a part of their academic curriculum.
- 8. KES Shroff College and St. Mira's College, Pune would encourage faculty exchange for teaching-learning.
- One Coordinator will be appointed by the First Party and Second Party respectively to administer and manage all the programmes and activities organized under said MOU. The coordinators will coordinate with the KES Shroff College and St. Mira's College, Pune in personnel.

#### 10. **DISCLAIMER:**

The parties do not intend this MoU to constitute, create, give effect to, or otherwise recognize a joint venture, agency, partnership, or formal business organization of any kind. Each party hereto shall act as an independent entity and neither shall act as an agent of either organization for other purposes.

## 11. NON-EXCLUSIVITY:

The agreements reflected by the provisions of this MoU are non-exclusive in nature and both the parties can enter into cooperative arrangements with other parties to suit their organization needs.

### 12. **COFIDENTIALITY:**

Both the parties shall keep confidentiality of the data received during the course of transaction. The Personal Data will not be used for any other purpose than regular framework information which is by nature, non-confidential or which is the public domain or which the party comes to know about other than through violation of any law or legal obligation, provided that such party may be entitled to disclose such information if legally required to be disclosed to a competent authority. Failure to maintain confidentiality shall entitle the affected party to terminate the MoU.

- 13. All disputes, differences and questions of any nature which at any time arise between the parties to this agreement or their respective representatives and assigns or any of them out of the construction of or concerning anything contained in or arising out of this agreement or as to the rights, duties or liabilities under it of the parties to it respectively or their respective representatives shall referred to arbitration under the arbitration and conciliation Act, 1996 or any statutory amendments or re enhancement thereto. The Arbitrations proceedings shall be held at Mumbai, India.
- 14. Any party may by notice in writing to the other parties change the address and / or addresses to which such notices are to be delivered or made.
- 15. No amendment or modification of this agreement shall be valid unless the same is made in writing by all the parties or their authorized representatives and specifically stating the same to be an amendment of

this agreement. The modifications / changes shall be effective from the date on which they are made or executed unless otherwise agreed to.

16. Court of jurisdiction for any dispute will be Bombay High Court. (Mumbai).

### ARTICLE 1:

The output of these collaborative efforts may be used by either or both parties, with the recognition of each party's contribution.

The Principals of KES Shroff College and St. Mira's College, Pune will be jointly responsible for working out operational details of the agreement between the two organizations and ensure property and effective implementation of the MoU.

Both KES Shroff College and St. Mira's College, Pune may add, modify, amend or delete any part of this agreement by mutual consent and understanding of the signing authorities.

#### ARTICLE 2:

The agreement will be in effect initially for a period of **Five** years from the date of signing this MoU by both the parties after which it may be reviewed for possible extension. Either party may terminate the agreement by written notification signed by the appropriate official of the institution initiating the notice. Such a notice must be received by the other party 90 (ninety) days period to the effective termination date.
