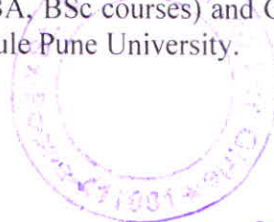
**Agenda 1 :** To present and finalize the time span for completion of the 8 non-CGPA credits proposed by the affiliating Savitribai Phule Pune University for the undergraduate (UG) programmes of B.A. BCom, BBA, BBA(CA), BSc(CS)] for completion over the three year degree programme.

**Resolution 1:** It was resolved that out of the 8 non-CGPA credit course, two compulsory non-CGPA credit courses of 2 credits each would be completed at the first year level, one non-CGPA credit course of 2 credits by the Second year level and the remaining 2 credits could be completed by the UG student between the second year and third year of the said programme i.e. between Sem, III, Sem IV and Sem V) at the discretion of the student. The same was approved by the Academic Council members.

**Agenda 2:** To formalise the conduct of the two non-CGPA credit courses at the first year undergraduate level [all streams], viz. Physical Education [Group I course] and Democracy, Election and Governance [Group I for BA, BSc(CS) and Group II for BCom, BBA, BBA(CA)] course declared as compulsory non-CGPA courses by the Savitribai Phule Pune University.

**Resolution 2:** It was resolved that the mandatory 2 non-CGPA credit courses of Physical Education [SPPU Group I course] and Democracy, Election and Governance [Group I for BA, BSc(CS) and Group II for BCom, BBA, BBA(CA)] course would be completed at the first year UG level [all streams] by Semester II. The Sports Director and the Head, Department of Politics and Public Administration would be the concerned faculty for maintaining a record of the evaluation of the respective courses. The said courses have been conducted at the First Year level in 2021-22.

**Agenda 3:** To propose Sanctuary (Value based education) as a 2 credit non-CGPA course to be categorized as a short-term course of not less than 1 week duration, of a minimum duration of 30 hours and 2 credits (Group VI of BA, BSc courses) and Group VII of BCom, BBA, BBA(CA) as suggested by the Savitribai Phule Pune University.



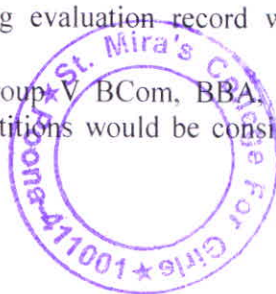


**Resolution 3:** It was resolved that Sanctuary (Value based education) could be categorized as a short-term course of not less than 1 week duration, of a minimum duration of 30 hours and 2 credits (Group VI of BA, BSc courses) and Group VII of BCom, BBA, BBA(CA) as suggested by the Savitribai Phule Pune University. It would be offered to UG students of all streams as a compulsory 2 credit non-CGPA course at the Second Year level for evaluation in Semester IV. In 2021-22, the course evaluation will be conducted in offline mode but w.e.f. 2022-23 the course conduct will be in offline mode but the learning resources for the same will be available on MOODLE and evaluation of the same will be in online mode. The concerned faculty for maintaining record of evaluation would be the Sanctuary Coordinator.

**Agenda 4:** To discuss and finalize the options to be made available to the undergraduate student for award of the balance 2 non-CGPA credits based on the Savitribai Phule Pune University's list of suggested non-CGPA credits.

**Resolution 4:** It was resolved that the undergraduate students could secure the 2 non-CGPA credits from the list of activities stated below (based on the groupings of activities as suggested by the Savitribai Phule Pune University. The UG student would have the choice of completing 2 activities of 1 credit each or engage in 1 activity of 2 credits. The options available will be:

- **Sports** [SPPU Group II BA, BSc; Group III BCom, BBA, BBA(CA)]:-Representation at College [1credit] / University/State level [2 credits] / International level [3 credits]. This option would be available for Sports students only across streams. The year-wise allocation per student would be to a maximum of 2 credits. The faculty in charge for maintaining record of evaluation of such Sports events would be the Sports Director of the College.
- **NSS** [SPPU Group III BA, BSc; SPPU Group IV BCom, BBA, BBA(CA)]:-Participation in NSS Camp [1 credit]; NSS with Youth Camp participation at national level [2 credits]; and Socio-cultural surveys [SPPU Group VI BA, Group VII BSc, [1 credit], [SPPU Group VIII BCom, BBA, BBA(CA) [2 credits]. It was resolved that across streams, participation in NSS activities including NSS Camp [1 credit] combined with a formal Socio-cultural Survey [conducted at the NSS camp] for award of another 1 credit. This option would be available only for NSS students. The NSS Programme Officer/s would be the concerned person/s for maintaining record of evaluation of these 2 credits.
- **Avishkar / Indradhanushya / Utkarsh /Anveshan /Awhan** –[SPPU Group IV BA, BSc; SPPU Group V BCom, BBA, BBA(CA)]:Participation at College level [1 credit] / Selection at University level [2 credits]/Winner at State level[4 credits]. It was resolved that student participation in Avishkar / Indradhanushya / Utkarsh /Anveshan /Awhan would be considered for advanced learners across all streams. The contact person for securing evaluation record would be a faculty from the concerned Programme stream.
- **Research Paper Presentations** [SPPU Group V BA, BSC]: Student participation in Research Paper Presentation at State level [1 credit] /National level [2credit] /International levels [3 credits]; [SPPU Group VI BCom, BBA, BBA(CA) student research paper participation at State and National level 1credit; International level [2 credits]. This option would be available for advanced learners only from across streams. The contact person for securing evaluation record will be the Research Coordinator.
- **Cultural activity** at College [SPPU Group V BCom, BBA, BBA(CA)] [1credit]: Participation in 2 inter-collegiate competitions would be considered for award of 1





credit. Since this option was available only to the B.Com and BBA students in the University list of suggested non-CGPA courses, it was resolved that the same would be available only for BCom and BBA students of the College. The concerned person for securing evaluation record would be a Commerce/BBA faculty representing the Cultural Committee.

- **Online Certificate Courses/MOOC:** max. 4 credits, minimum of 15 hours [ SPPU Group VIII BA, BSc]; [SPPU Group X - BCom, BBA, BBA(CA)] Under this category, the College would like to categorize the following courses:
  - **IBM Skill Build courses** [2 credit] for regular learners across all streams. There would be a specific IBM course coordinator for securing evaluation and certification record.
  - **MILE:** or the Mira International Learning Exchange courses [2 credits] for advanced learners, across all streams. The concerned faculty for the MILE Courses will be the MILE Coordinator along with the individual MILE course coordinators responsible for maintaining course evaluation and completion records.
  - **Personality Development:** The online, self-paced course on Personality Development [2 credits] for regular learners of B.Sc(CS) and B.A. only. This is because Personality Development is categorized as an Add on course for the BBA and BCom, approved in the earlier Academic Council meeting. The Course Coordinator maintaining the record of course conduct would be a faculty from the concerned BSc(CS) and BA departments respectively. The appointment of the Co-ordinator would be on a rotational basis. Note: The approval for conduct of this course for the BSc(CS) was sought from the esteemed Academic Council earlier. The same has been completed at the SYBSc(CS) level in Sem IV of the academic year 2021-22. This course will be considered for the BA programme for completion by Sem V [2022-23].
  - **Other:**[SPPU Group VIII BA, BSc]; [SPPU Group X - BCom, BBA, BBA(CA)] [2 credit] Any other online certificate course/MOOCs course completed by the student, across streams.

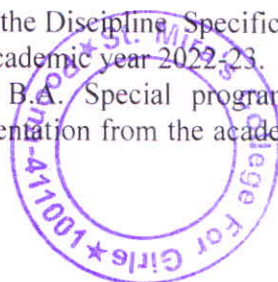
The Academic Council members appreciated the courses on offer for fulfilment of the 8 non-CGPA courses. Dr. Meena Chandavarkar, further suggested that the College consider the possibility of tie-up with an agricultural college or university for conduct of self-paced Summer Certificate Courses like Organic Farming, Ornamental Fisheries, Mushroom Cultivation, setting up of a Green House and the like which could be explored to provide employability to students from an agrarian background.

**Agenda 5:** To propose inclusion of Internships of 1 or 2 credits as part of non-CGPA credits (depending on duration) for advanced learners of BSc(CS).

**Resolution 5:** It was resolved that for BSc(CS), internships as an optional non-CGPA credit could be considered for award of 1 or 2 credits (depending on duration) for advanced learners. Internships of 1 month (30 hours) could be awarded 1 credit and a certificate, while internships for 2-3 months of 60 hour duration could be awarded 2 credits and a certificate. The concerned faculty responsible for compiling record of internships would be the Computer Science Coordinator.

**Agenda 6:** To present the '+1' credit details for the Discipline Specific Courses of B.A. Special (S3 and S4) for implementation w.e.f. the academic year 2022-23.

**Resolution 6:** The '+1' credit details for the B.A. Special programmes of English, Psychology, Sociology and Economics for implementation from the academic year 2022-23,





were presented for Semester -wise for Special III and Special IV papers and approved by the Academic Council members.

**Agenda 7.** To consider inclusion of T.Y.B.Com internships as an optional component of the '+1' credit Skill Enhancement Component (SEC) for T.Y.B.Com specialisation papers w.e.f. the academic year 2022-23.

**Resolution 7:** It was resolved that internships at the T.Y.B.Com level for specialisation subjects of Business Administration, Business Entrepreneurship, Marketing, Costing and Banking & Finance would be considered as an optional component [for advanced learners] under the +1 Skill Enhancement Component(SEC) of the aforesaid TYBCom specialisation papers w.e.f. the academic year 2022-23. In the initial phase, the Commerce department will explore internships upto 5% of the strength of the students in the specialisation subject and gradually move towards embedding the same.

**Agenda 8:** To intimate to the Academic Council about the non-requirement of the online, add on 2 credit Sustainable Development (SDG) course at the TYBCom level, as per the SPPU's latest circular no.11/2022 dated 13-01-2022.

**Resolution 8:** The Academic Council was intimated about the non-requirement of the previously approved online, add on 2 credit Sustainable Development Goal (SDG) course at the TYBCom level in the academic year 2022-23, (as per the SPPU's latest circular no.11/2022 dated 13-01-2022).

Dr. Supriya Patil, University nominee suggested that since the SDG course was already approved by the College Board of Studies and the Academic Council at previous meetings and represented a contemporary topic, it could be offered as a non-CGPA credit course at St. Mira's College. In response, Principal In charge, Dr. Jaya Rajagopalan and Dr. Rama Venkatachalam, HoD, Commerce Department stated that since the SDG course content was purely academic, it would be offered to the students as an additional credit course in the next academic year.

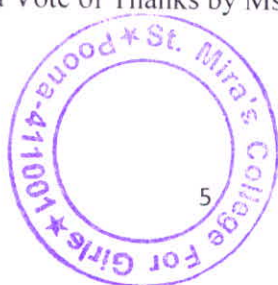
**Agenda 9.** To discuss any other related issue/topic with the permission of the Chair.


**Resolution 9:** The Principal In charge, Dr. Jaya Rajagopalan announced that the College had been recognized as a PG Research Centre for Women's Studies, by the Savitribai Phule Pune University recently. She announced that we have 6 registered PhD students with 2 in-house and one Visiting Research Guide. The PhD Scholars are expected to submit their research proposals by April 30, 2022. All Academic Council members were appreciative of this fact.

After congratulating the Principal In charge about this positive development, Dr. Meena Chandavarkar suggested that short term courses for Research should be introduced by the Centre. In response, Principal In charge, Dr. Jaya Rajagopalan expressed appreciation of the suggestion and added that the College is conducting SPPU's Dept. of Women's Studies Certificate Course in Gender and Culture on campus.

It was further decided by the Academic Council members that the case of the TYBA Generic Elective (GE) credits and modalities of the GE syllabi transaction would be taken up for discussion in the successive Academic Council meeting in May-June 2022-2023.

The meeting concluded with a Vote of Thanks by Ms Rekha Kankariya.

**Resolution:** It was approved by the members.


**Agenda 4:** To present for approval, the syllabi for Value based Education.
