Terms and Conditions: -

- 1) The above posts have been sanctioned as per the workload calculated taking into account the number of admitted students in the aided faculties / divisions / subjects operating in the college.
- 2) Faculty/Divisions/Subjects and the number of students on roll approved by the university according to the proposal submitted by the college for sanctioned posts are mandatory.
- 3) The workload has been calculated taking into account the number of students required for approval of grant.
- 4) A batch (group) of the number of students prescribed as per government rules will be mandatory for Practical.
- 5) Lectures/Practical, Tutorials (Lesson Instruction), Project Work hours will be mandatory as per the norms prescribed by the Government.
- 6) It is mandatory to certify the roster by the prescribed authority as per the prevailing reservation policy of the government and as per the posts approved to the college.
- 7) In case of decrease in the number of students in the next academic year or if the workload of the aided department decreases due to other reasons, the number of sanctioned posts will be reduced.
- 8) Action should be taken as per the provisions of the prevailing government resolution regarding the adjustment of additional teaching/ non-teaching staff. No permission will be given for recruitment without induction of additional staff.
- 9) Posts are sanctioned based on the granted workload of the college. For recruitment to permissible posts, it is necessary to submit a proposal and obtain a no-objection certificate separately as per the prevailing policy and function of the government.
- 10) Permissible Posts Recruitment should not take place without the prior permission of the Govt. In case of non-compliance appointment without Government permission / Irregularity regarding appointment at any level, payment of salary for the said post will be invalidated. The entire responsibility of such appointments will be with the concerned management and the college.
