The reporting trustee, Shri. Suryakant Ramrao Kulkarni has filed present change report for deletion of three trustees recorded in the Schedule-I register due to their resignation. Reporting trustee nominated three trustees for insertion of Managing Committee members unanimously substituted in the meeting of managing committee meeting dtd. 10.03.2009. In support of his claims and contentions, he has filed various documents (Exh. 02 to 12) on record.

From the proceeding dtd. 10.03.2009 it reveals that the resignations were put up before the managing committee meeting and the resignations are accepted and new trustees were appointed, unanimously. Notice of inquiry was issued by this office vide Exh. 04, but nobody appeared before this authority although notices were served to them vide Exh. 05 & 06. The applicant has filed no objection letters of out going trustees at Exh. 03, consent letter of incoming trustees at Exh. 02. Out going trustees have filed his affidavit contending that he has no objection to the present change report at Exh. 08 to 10. Applicant has filed his affidavit at Exh. 11 contending the resignations are put up before managing committee and all the contents are true and correct in the change report.

It is significant to note that nobody has filed objection for acceptance of change report in question. Hence, the matter is an uncontested one. Considering all these aspects, I came to the conclusion that the reported change is legal and valid one, hence, I proceed to pass the following order.
